Aequs SEZ Private Limited (ASEZPL) has filed an application before the Hon'ble Karnataka Electricity Regulatory Commission (Hon'ble Commission) for approval of Annual Performance Review for FY '18 and Annual Revenue Requirement (ARR) for the Distribution and Retail Supply Business for the control period FY '20 to FY '22 and Tariff Petition for FY '20 of Aequs SEZ Private Limited under Section 61 & 62 of the Electricity Act, 2003 read with relevant Regulations of KERC (Tariff) Regulations including KERC (Terms and Conditions for Determination of Tariff for Distribution and Retail Sale of Electricity) Regulations, 2006. The Hon'ble Commission is in the process of considering the same.

The summary of the application are as below:

1. Annual Performance Review for FY '18

I. There is a surplus of INR 0.04 Cr in the Profit & Loss account. In the prayer Hon'ble KERC has been requested to kindly allow this amount to be retained by AEQUS as it has suffered losses in the earlier years. (Accumulated losses as on FY'18 is INR 0.88 Crs)

II. It is also submitted that as part of the true-up, if any change in the power purchase rate is approved by Hon'ble KERC for FY'18, then the entire increase should be passed on to our consumers.

2. Annual Revenue Requirement for FY '19

A gap of INR (0.38) Cr. expected in the Profit & Loss account. ASEZPL will approach the Hon'ble Commission for true-up of numbers after final audited numbers for FY'19 are ready.

i. For FY'20, The GAP is INR (0.22) Crs. which translates to 9 Ps/KWh. of energy sold.

ii. As consumer's interest is paramount, with optimisation in PP, Aequs management, has decided not to pass on this burden to our consumers at this stage.

iii. ASEZPL requests Hon'ble Commission to retain the same power purchase rate for FY '20 also as approved by Hon'ble Commission for FY '19 in tariff order dated 14th May 2018 and if any increase, the same has to be passed on to our consumers through tariff increase.

iv. As any FAC approved by Hon'ble KERC during the course of FY '20 is a pass through, it is neither considered as revenue (Refer D2) OR as expenditure (refer D1) in the ARR filed. ASEZPL would pay the supplier and recover the same from our consumers at approved rates fixed by the Commission from time to time.

v. Aequs would strive hard to reduce the above GAP of INR (0.22) Crs in FY '20 through better sales and efficiency improvement. If there is any GAP uncovered for FY '20 as per its audited accounts, Aequs would come before Hon'ble Commission for True-Up.
